Vetting / Class Inspectors will NOT be allowed to board until two hours after cargo has commenced.

Provisions / Spares/ Lube Deliveries-----First delivery to be scheduled two hours after commencement of cargo operations, with at least one hour interval between deliveries.

Ensure portable gangway is rigged for placement upon arrival.

Vessel's crew to connect hoses @ ships manifold.

Vessels calling CTI-3 must be aware of activity on the adjacent Berth(CTI-2). Sufficient room for safe mooring must be confirmed before starting in .

Marine Docks, Storage Tank Fields and Offices , are Restricted Access Areas

Only Personnel with a TWIC CARD and a COLONIAL ID CARD reflecting a TWIC ID Number will be allowed to enter the facility

Non-TWIC holders must be escorted by an authorized TWIC holder who possesses both a TWIC and Colonial Identification card

One escort is required for every five non-TWIC holders.

Escorts are required to wear Orange vest. Non-TWIC card holders wear YELLOW vest-

Escorting requires side by side accompaniment or line of sight contact.
